

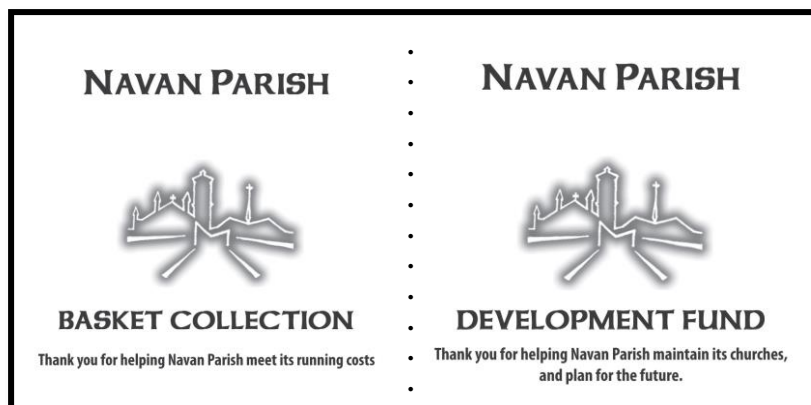
# Envelope Collection 2020 – 2021

## Navan Parish

*Navan Parish operates a double-envelope donor system. If you are not already contributing to the Parish by envelope, please read the following to understand how the Parish benefits from the envelope collection.*

### ***What is the Parish Envelope?***

The envelope has two parts, like this:



The “***Basket Collection***” allows the Parish to meet its daily running costs. The “***Development Fund***” allows the Parish to maintain its churches and other buildings, as well as planning for future development.

### ***What is the purpose of the double-envelope?***

The Parish can include your contributions to both collections in your annual total contribution to the Parish. A total annual contribution of €250.00 or more may be eligible for an Income Tax rebate to the Parish.

## Examples of Income Tax Rebate for Navan Parish

<u>Your annual donation</u>	<u>Revenue rebate to Parish</u>	<u>Total value of your donation</u>
€ 250.00	€ 112.32	€ 362.32
€ 500.00	€ 224.64	€ 724.64
€ 750.00	€ 336.96	€ 1,086.96
€ 1,000.00	€ 449.27	€ 1,449.27

*For the Parish to benefit from an Income Tax Rebate, the parishioner must return a completed CHY3 or CHY4 Cert to the Parish, and must have paid the equivalent amount or more of the rebate in Income Tax in that calendar year.*

In 2019, the Income Tax Rebate to the Parish amounted to **€46,239**. This represents a significant income to the Parish and one which we hope to increase!

### ***What do I need to do now?***

The Parish asks that you complete the form below and return it to the Parish Office or to the sacristies at St. Mary's or St. Oliver's as soon as possible.

### ***When will I receive my new envelope box?***

The new envelope boxes will be available for collection at Sunday Masses during September. Alternatively, the Parish can arrange for the new box to be delivered to your home.

**REMEMBER!** A total annual donation of €250.00 or more can allow the Parish to benefit from an Income Tax Rebate!
